2. **PAYING A PET DEPOSIT OF \$200** that is refundable at vacate or when my pet is no longer in my unit.
3. **ANY DAMAGE OR INJURY** caused by my pet.
4. **PROMPTLY DISPOSING OF PET WASTE** in a plastic bag and placing it in the trash.
5. **UPDATING PET REGISTRATION ANNUALLY** or as requested by Homes for Good.
6. **USING A LEASH OR CARRIER** when my pet is outdoors, unless my unit has a private fenced yard.
7. **KEEPING MY PET AND ITS NOISE UNDER CONTROL** at all times.
8. **NOT ALLOWING MY PET IN INDOOR COMMON AREAS**, except for entrances and exits.
9. **NOT ALTERING MY UNIT** to accommodate my pet.
